

AND NOW, comes Applicant, Hanoch Edelman, t/d/b/a Adam's Moving & Hauling, by and through his attorney, Richard T. Mulcahey, Jr., Esquire, and Clemmer Moving & Storage, Inc. and Shelly Moving & Storage, Inc., by and through their attorney, William H. R. Casey, Esquire, and join in this Restrictive Amendment and Stipulation as follows:

1.    The above-captioned application is hereby amended so that the authority sought shall now read as follows:

To transport household goods, in use, between points in the Counties of Bucks, Montgomery and the City and County of Philadelphia, and from points in the said City and Counties to points in Pennsylvania;

with the aforesaid right subject to the following conditions:

provided, however, that the transportation rendered hereunder shall be between points in the City and County of Philadelphia, the City of Norristown, Montgomery County, and five (5) statute miles from the limits of said City, and Lower Merion Township, Montgomery County, to points in Pennsylvania.

2.    Based upon the Restrictive Amendment set forth in Paragraph 1 above, and conditioned upon its acceptance by the Pennsylvania Public Utility Commission and any Order issued being consistent therewith, Protestants agree to withdraw their Protests

to the Application as amended. Protestants desire to remain parties of record so as to receive copies of any Orders issued by the Commission in the proceeding.


