I am currently in the process of completing our 2004 PUC Assessment Report. This report was mailed to us with the company name "Bilran Excavating Company" (PUC ID # 701397).

We changed our name from "Bilran Excavating Company" to "Horst Excavating Company" several years ago. In June, 2003, we sent you letters and documentation of the name change, including the Forms "E" and "H" that you required. In fact, our insurance company tells me they sent these 2 forms by certified mail.

In 2004, you still had our name as "Bilran", and we again notified you of the name change. This year, you still have our name as "Bilran" on the Assessment Report. I called and have spoken to Mr. Pete Marzolf at the PUC. He has been very helpful, and informed me that you do have record that we requested the name change, but did not have forms "E" and "H" on file.
