APPLICANT'S RESPONSES TO PARAGRAPH 12a

1. The Sales Agreement is attached hereto as Exhibit "A."

5. Any unpaid business debts of Transferor will be satisfied out of the proceeds of the purchase price for the rights.

6. The Applicant is familiar with the Department of Transportation Safety Requirements and will comply with such requirements.

7. The Applicant has been involved in the trucking industry for over forty (40) years. He is familiar with all phases of the operations of a certificated carrier.

AGREEMENT

THIS AGREEMENT made this 15th day of March, 1990, by and between HARRY E. CULBERTSON, INC., d/b/a H.E.C., INC., (hereinafter referred to as "Transferor") and DOMENIC F. TADDEI, (hereinafter referred to as "Transferee").

WITNESSETH:

1. Transferor agrees to sell and transfer unto Transferee those rights granted to it by the Pennsylvania Public Utility Commission under Docket No. A00101950, reading more particularly as set forth in Exhibit "A" attached hereto and made a part hereof.

2. Transferee agrees to pay the Transferor as consideration for the said rights the sum of Thirty-Nine Thousand Two Hundred Fifty and 00/100 (\$39,250.00) Dollars.

The consideration for the transfer shall be paid as follows:

Four Thousand Two Hundred and Fifty and 00/100 (\$4,250.00) Dollars to be paid to Harry E. Culbertson, Inc., as a good faith down payment at the time of the execution of this Agreement subject to the provision that if the transfer is not approved by the Pennsylvania Public Utility Commission or said

transfer is denied for any reason, other than a default or refusal to consummate on the part of the Transferee, then said down payment shall be immediately returned to the Transferee upon written demand forwarded by Transferee to Transferor and there shall be no further liability upon the parties. It is further provided that upon approval of the transfer of the authority by the Pennsylvania Public Utility Commission that the balance of the consideration for the said rights shall be tendered at the time of settlement.

3. The parties hereto agree to the following miscellaneous provisions:

a. The cost of transfer and the processing of the transfer of said rights of the Pennsylvania Public Utility Commission shall be borne by the Transferee;

b. This Agreement shall be binding upon and enure to the benefit of the respective parties, their successors and assigns, heirs and personal representatives;

c. Neither this Agreement nor any term or provision hereof may be changed, waived, discharged or terminated orally, or in any manner other than an instrument in writing signed by the parties hereto;

d. This contract shall be construed under and governed by the laws of the Commonwealth of Pennsylvania. 4. The parties hereto shall do all things required to complete and file with the Pennsylvania Public Utility Commission the Application for the approval of the transfer of the right described herein and shall do all things which may be required for the expeditious processing of the Application.

5. Transferor agrees to hold Transferee free and harmless from any and all liabilities of any nature whatsoever against the Transferee and agrees to file such reports as may be required by the Pennsylvania Public Utility Commission with reference to operations conducted by the Transferor up to the time of settlement. Transferee further agrees to pay any assessments which may be made by any agency by reason of operations conducted by Transferor up to the date of settlement. If Transferee pays such assessments by reason of an assumption of said obligations, then, in such event, Transferor shall reimburse Transferee for such payment upon written demand if Transferee shall make such a demand.

6. Settlement shall be made at the office of Donald M. Davis, Esquire, or at some other place as the parties shall agree, within ten (10) days after final approval of the said transfer by the Pennsylvania Public Utility Commission. IN WITNESS WHEREOF, the parties hereto intending to be legally bound, have executed this Agreement on the date above set forth.
