





SUPPLEMENTAL REPORT AND ORDER MODIFYING CERTIFICATE OF PUBLIC CONVENIENCE

SERVICES, INC., a corporation of the Commonwealth of Pennsylvania, dated March 16, 1976, for modification of the report and order issued under date of October 18, 1971, and the certificate of public convenience issued thereunder, and having been duly presented in accordance with the rules of the Commission and full investigation of the matters and things involved having been had, and it appearing that the rights granted herein are in effect a transfer of the rights which have been held by ELIZABETH LUCERA, under report and order issued at A. 98068 on September 10, 1973 and the certificate of public convenience issued thereunder, which certificate will be subsequently cancelled, as of the date of this order, upon compliance with the tariff requirements of the Commission by J.C. SERVICES, INC., a corporation of the Commonwealth of Pennsylvania the Commission finds and determines that approval of the proposed modification is necessary or proper for the service, accommodation or convenience of the public; THEREFORE,

NOW, to wit, August 11, 1976, IT IS ORDERED: That the report and order issued under date of October 18, 1971 and the certificate of public convenience issued thereunder, be and is hereby modified and amended so as to include the following rights:

To transport, as a Class D carrier, household goods and office furnishings, in use, fixtures and contents of stores and equipment, in case of movings, between points in the city and county of Philadelphia.

To transport, as a Class D carrier, household goods and office furnishings, in use, fixtures and contents of stores and equipment, in case of movings, from points in the city and county of Philadelphia, to other points in Pennsylvania, and vice versa, provided that the rights, powers and privileges hereby granted shall be limited and restricted to ten (10) trips per month, and subject to the filing of a monthly

subject to the following conditions:

That the approval hereby given is not to be understood as committing the Commission, in any proceedings that may be brought before it for any purpose, to fix a valuation on the rights to be acquired by applicant from the present certificate holder equal to the consideration to be paid therefor, or equal to any value that may be placed thereon by applicant, or to approve or prescribe rates sufficient to yield a return thereon.

That applicant shall not record in its SECOND: utility accounts any amount representing the rights herein granted, in excess of the actual cost of such rights to the original holder thereof.

That the applicant charge to Account 1550, THIRD: Other Intangible Property, \$3,000, being the amount of the consideration payable by it for the rights and going concern value attributable thereto; less any amount recorded under condition 2 above.

IT IS FURTHER ORDERED: That the applicant will not be permitted to operate or engage in any transportation granted herein until compliance with the requirements of the Public Utility Law relative to the filing and acceptance of a tariff establishing just and reasonable rates.
