

Dear Mr. George:

Under date of 8-29-94, the Secretary's office transmitted to you the Commission's compliance order adopted 8-18-94, evidencing approval of the above application which is in effect a transfer of the rights formerly held by Budget Moving & Storage Company, Inc. at A-00110342. The letter transmitting the order directs attention to the requirement for the filing of a tariff.

In accordance with the provisions of Pa. Code, Title 52, Section 23.13(c), you should immediately arrange to file adoption supplements with us whereby the tariff of the former operator will become the tariff of the latter, and no change in rates is permitted to cover the transfer of rights. 
