The above-captioned case charging a violation under Section 8 of National Labor Relations Act, as amended, has been carefully investigated considered.

As a result of the investigation, I find that the charge lacks merit. The charge alleges that D. Cristinzio Inc. ceased its Philadelphia operation, moved to New Jersey and opened a non-union company, T&N Van Services, to avoid bargaining with the Union. The investigation disclosed that David Nelson, Russ Taddei, Jr., Don Taddei, Jr., and Kenneth Taddei, all of whom had held management positions with D. Cristinzio, decided in early 1992 to leave D. Cristinzio, Inc. and form their own company in Cinnaminson, New Jersey, T&N Van While T&N hired six employees who were formerly employed by D. Cristinzio, Inc., and who are performing the same type of moving work that they performed at D. Cristinzio, the evidence established that T&N has different ownership, different supervisory structure, a different location, different labor relations, and different wages and benefits. Further, while T&N purchased some of the assets of D. Cristinzio and some customers of D. Cristinzio have chosen to use T&N for their moving needs, the equipment was purchased for fair market value and the customers were solicited by T&N, in competition with other area moving companies. In view of the lack of common ownership, I find no alter ego relationship between D. Cristinzio and T&N. In addition, as T&N merely acquired a portion of the equipment and customers of a moribund company, solicited in competition with other companies, I find that the employing industry is sufficiently fragmented as to preclude a finding of successorship between D. Cristinzio and T&N Van Services. See Co-Op Trucking Co., Inc., 209 NLRB 829 (1974)......Accordingly, I am refusing to issue Complaint in this matter...


