


My client, Dominic F. Taddei, who holds a PUC Certificate as docketed above has recently incorporated his business under the name "Tad's Delivery Service, Inc."

Dominic F. Taddei remains the sole owner of the stock and is the President of the Corporation. There has been no change in the ownership nor control of the business.


At this time, we would respectfully request that the authority issued to Dominic F. Taddei under docket number noted above be transferred into the name of Tad's Delivery Service, Inc.


