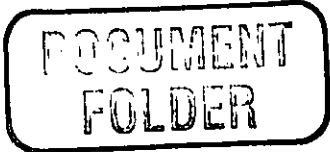

BY THE COMMISSION:

This matter comes before the Commission upon letter-request of Russell J. Golden, t/d/b/a Predator Trucking Company that his contract carrier permit be changed to stand in the name of Predator Trucking Company pursuant to 52 Pa. Code §3.381(a)(7)(ii).

Upon review of the request, it appears that the necessary filings have been made and that there has been no change in the ownership or control of the business; THEREFORE,

IT IS ORDERED: That the request be and is hereby approved and that the permit issued to Russell J. Golden, t/d/b/a Predator Trucking Company be changed to stand in the name of Predator Trucking Company.

IT IS FURTHER ORDERED: That the permit holder shall effect the name change on his insurance and tariff filings with the Commission.
