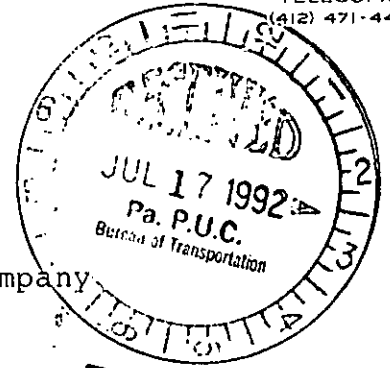

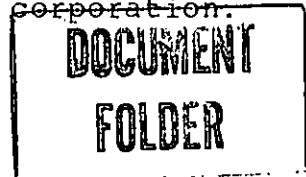
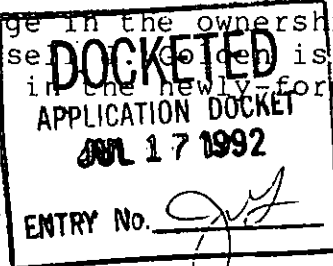
I. Russell J. Golden, t/d/b/a Predator Trucking has authority from the Commission at Docket No. 00109468.






