Dear Mr. Vuono:

Under date of 10-2-91, the Secretary's office transmitted to you the Commission's compliance order adopted 9-26-91, evidencing approval of the above application which is in effect a transfer of the rights formerly held by Shoreline Moving Systems, Inc. at A-00107274. The letter transmitting the order directs attention to the requirement for the filing of a tariff.

In accordance with the provisions of Pa. Code, Title 52, Section 23.13(c), you should immediately arrange to file adoption supplements with us whereby the tariff of the former operator will become the tariff of the latter, and no change in rates is permitted to cover the transfer of rights. To assist you in meeting this tariff requirement, we are enclosing three copies of the necessary supplement to be properly executed by you, the original and one copy of which must be returned to us for filing and the remaining one to be retained for your records. Upon the proper filing of the adoption supplements, the tariff requirements will be satisfied.

We represent South Hills Movers, Inc., the applicant in the above proceeding which involves the purchase of all of the Pennsylvania intrastate operating rights held by Shoreline Moving Systems, Inc.

Shoreline is in bankruptcy and, as a result, there have been some delays in meeting the Commission's compliance requirements, etc. This will confirm that the transaction was consummated by the parties today. Simultaneously, South Hills Movers, Inc. has transmitted to the Commission a check in full payment of the assessments due from Shoreline and has transmitted adoption supplements to meet the Commission's tariff requirement.

Accordingly, we believe that all compliance matters have been effected. We ask that the Commission promptly issue a letter confirming that fact and advising applicant that it may begin using the operating rights.
