

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) and Weekdays 5:01 PM to 7:00 AM: 4 hours at rates named in Columns 1 and 4.

NOTE 2 - Rates in Column 4 apply only from 5:01 PM to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE AA - A flat charge based on one-half hour at the applicable transportation rates shown in Columns 2, 3, or 4 is applicable when distance from original point of origin to final destination is 10 miles or less.

NOTE BB - A flat charge based on one hour at the applicable transportation rates shown in Columns 2, 3, or 4 is applicable when distance from original point of origin to final point of destination is more than 10 miles but not exceeding 25 miles.

NOTE CC - A flat charge based on one and one-half hours at the applicable transportation rate shown in Columns 2, 3, or 4 is applicable when distance from original point of origin to final destination is more than 25 miles (to 40 miles inclusive).


