Answer to Respondent plead

PECO alleges my complaint was, "I said my electricity was terminated without notice"! **I DENY and consider this MALICE! I do acknowledge, I received a termination notice from PECO. One and, ONLY ONE! My shut off notice was in the amount \$101.32. PECO states in New Matter Response, "I was sent a shut off letter for \$2937.93"! I DENY ANY ALLEGED MALICE!**

I was a consistent caller to PECO making efforts to correct my **Crisis!** The responses to my efforts to settle this **Crisis** from PECO were **CONTRADICTING** amongst different employees and supervisors. Some voices from PECO said, I was given a ten day shut off notice by a recorded telephone call, and some employees said it was shut off notice by mail. Some said I received two notices by mail. Some didn't even

My quest to seek why I have no electric was sought through PECO and PECO's supervisors. I was channeled to my State Representative and then went to PUC, to this forum that I presently find myself today.

On October 10th 2015 the informal complaint BCS issued a decision dismissing my case. **I acknowledge that with no regret!**

After speaking to the respected investigator CLEOTILDE FLORES who **INTENSELY LISTENED** to every word I had said! She told me that there are two sides to every story, and she's going to give PECO a call and give them just as much respect as she gave me. I contacted her the following day. She said she talked to PECO, and she firmly recommended I pursue my case! She did not tell me why! Buy she did say, "I cannot order PECO to turn on your power at my level".

PECO brings up theft of service on January 4th 2013. **I ACKNOWLEDGE WITH NO REGRET**, I wish they really didn't; bring this up, It's a very sore subject with my family and I in early to mid December 2012, I received a shut off notice from PECO. I don't; recall the exact dollar amount at this time. I'm sure PECO would have a copy of the shut off notice. **Regardless of what they said in (Statement #7 of the Informal Complaint Report with PUC!)**

After receiving that shut off notice I contacted PECO. I attempted several times to make some type of payment arrangements. My last attempt, I discussed this issue for close to two hours with a PECO supervisor. Like I said, I don't; remember the exact dollar amount but I remember I had \$400 I could have given to PECO. I distinctly remember not being too far from the dollar amount they would accept. I can honestly say that the man that I spoke with seemed to be true gentleman! During this 2 hour conversation, I begged and pleaded with this gentleman! I explained to him, at this time, my daughter and granddaughter were living with me. I continued begging and pleading with him, **please do not shut off my electricity, it's Christmas. My 4 year old granddaughter is here!** Please don't shut off the electric to her Christmas tree, she's waiting for Santa Claus! This gentleman told me once it reached the point of being shut off there was no turning back. **That was PECO's policy!** On December 18th of 2012 when my electric was terminated!

~~PECO and BSC could never comprehend, from the paper and ink you're reading, the heart wrenching emotions we went through that day and the days after. I choose not to go into detail for my own mental health, on what occurred in my home on December 18, 2012.~~

On December 19, 2012, I purchased a generator for approximately \$400. This \$400 was set aside for PECO and the \$400 was unacceptable to PECO! On December 20th of 2012 approximately 2:30 a.m. the fire company was called, Emergency Vehicle were all over my street. The newly purchased generator was on fire, shooting 30 feet of flames in the air! **By the grace of GOD, no one was hurt and there was no damage done to my**

home or neighboring homes! We had found out that this particular unit had a defect and was replaced a week or two later!

I called PECO approximately the 20th of December 2012, and explained my situation. PECO's response to me was **"Well! If you had put the money toward your electric bill, your electric would be on now!"** At this point I realized I was beating a dead horse!

After what I experienced on December 18th of 2012, I realized today! If it was any other week of the year, other than Christmas with a 4 year old child in my home, my actions would have been the same as they were in October and November of this year. **I stood firm, without electric for approximately 45-50 days!** I would have pitched a tent and build a campfire in my backyard, before I would give PECO the opportunity to call me a thief in any other situation!

My quest that brings me to this forum today:

I ask you, WHO WOULD FEED THE BELLY OF A BEAST WHO HAS NO REMORSE FOR DEPRIVING A CHILD THE ARRIVAL OF SANTA CLAUSE? I consider the shut off on December 18, 2012 an act of **EMOTIONAL CHILD ABUSE WITH LONG TERM EFFECTS!**

A MEGA GRINCH stole Christmas from my 4 year old granddaughter!

This Act **NEEDS** to be made **Illegal!** On the dates of December 17th through December 27th of a calendar year, **No utility company should have the right to turn off power, when children of age are waiting for the arrival of Santa Claus!**

I'd like to propose to my judge and this Forum! To go through the proper procedures to establish Angel's Law! My granddaughter is named Angel, and No utility company should have the power to steal away our children's childhood dreams of the arrival of Santa Claus! Most children who wait for Santa Claus don't know what electric is, or even the concept of money being involved with it **December 17th through December 27th** brings about the concept of Angel's Law!

September 29th 2015 the termination of the electric at 120 Rosemary Avenue in Ambler PA 19002 – was an act of **MALICE WITHOUT DOUBT!**

The replacement generator was running on and off for less than two weeks on this past illegal shut off. The township called my family and told my family that they were willing to condemn the house if I continue to run my power through that generator. They also said that 120 Rosemary Avenue should not even be running a generator due to a fire in 2012! I gathered up all the paperwork I had from PECO and PUC, went to the township and showed them my paperwork. They looked at me shockingly! They then allowed me to run my generator as needed until this matter was settled! Needless to say, **I'm still the topic of the town!**


