Please accept this appeal of the penalty levied against our company in the captioned matter.


Please note, respectfully:

1. At no time has our company not had valid, appropriate insurance in-force. Enclosed is a copy of the current policy declarations from Philadelphia Insurance Cos. Effective on August 1, 2015, upon the expiration of our previous coverage.
2. Please see enclosed correspondence with the PUC enclosed in which I attempted to get a blank copy of form E to complete. Note that I am the insurance agent also on the policy, and that the PUC essentially refused to provide me with a copy of the form.
3. Please see enclosed correspondence with the insurer in which they had indicated that the form was being filed.

Because of the attached, (1) I never intended to, nor did, violate the requirement of maintaining insurance, (2) I made an effort, rebuked by the PUC, to take control of form E, and (3) I had been given assurance by Philadelphia Insurance Cos. That they were filing the form. Thus, I never disregarded the issue.

I respectfully ask that the penalty be vacated in light of these facts.

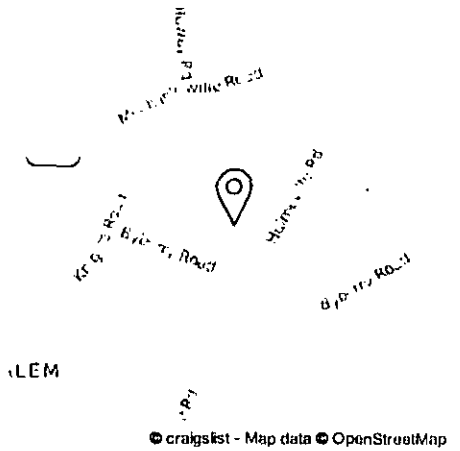

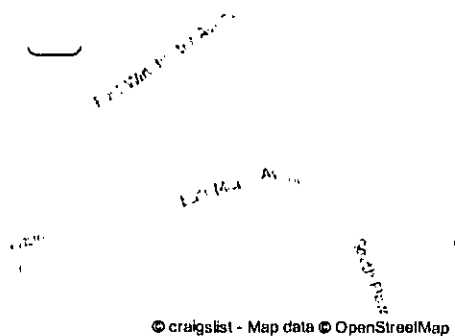


