Dear Madam Secretary,

On August 26, 2010, Discount Energy Group, LLC (“Company” “DEG”) filed an application seeking to become a licensed electric generation supplier (EGS) in the service territories throughout the Commonwealth of Pennsylvania. On March 17, 2011, the PPUC issued the license for the Company to Supply electricity throughout the Commonwealth under Docket No. A-2010-2199551. On January 15, 2014 DEG submitted a notice “In the Matter of the Acquisition of Discount Energy Group, LLC in accordance with 52 Pa. Code § 54.1-54.9 Docket No. A-2010-2199551. On April 27, 2015, Discount filed a request that the Commission change the name on its license to provide electric generation services as a supplier to Town Square Energy East, LLC (Town Square). On July 21, 2015 the Commission approved the name change.

Pursuant to Town Square’s ongoing obligation to inform the Pennsylvania Public Utilities Commission (“PPUC” “Commission”) of material changes to its business operations, the Company herein provides Notice, that the organization of which it is a part has undergone an update in structure.

Prior to November, 2015, Town Square was a wholly-owned subsidiary of Aspurity Holdings LLC (fka Twin Cities Power Holdings LLC) under Krieger Enterprises. In November, Aspurity Holdings, LLC distributed 100% of the equity interests of Krieger Enterprises to the common equity ownership. Krieger Enterprises has the same ultimate upstream (common equity holders) ownership as they had prior to the distribution.

Aspurity Holdings, LLC is a publicly reporting entity with most recent filings available through the Securities and Exchange Commission (SEC) by searching “Aspurity” from this URL: <http://www.sec.gov/edgar/searchedgar/companysearch.html> where the restructuring of the

company is detailed, for further information, beginning on page 54 of the most recent 10Q public filings.


Organizational charts that detail the corporate structure before and after the update are depicted in Exhibit "A," attached.

Town Square Energy East has changed its address. There will be no change in the primary contact personnel, however the business address and telephone number for staff involved in investigating complaints and investigating regulatory matters or emergency matters has changed. Also the mailing address for customer service and complaints has changed. See Exhibit "B" for details. The toll-free telephone/fax number for customer service and complaints will not change.

Since Town Square will continue to provide electric generation supplier services to residential customers it is required to comply with, and be governed by, applicable Chapter 56 residential service regulations as set forth in the Commission Order Guidelines for Maintaining Customer Service at the Same Level of Quality Pursuant to 66 Pa. C.S. §2807(d), and Assuring Conformance with 52 Pa. Code Chapter 56 Pursuant to 66 Pa. C.S. §2809(e) and (f), at Docket No. M-00960890 F0011, Order entered July 11, 1997. Town Square herein notes that it will continue to remain in compliance with all applicable rules, regulations and orders as promulgated by the Commission, past, present and future. No terms or conditions for any customer in Pennsylvania will change and they will continue to receive uninterrupted quality service from Town Square.

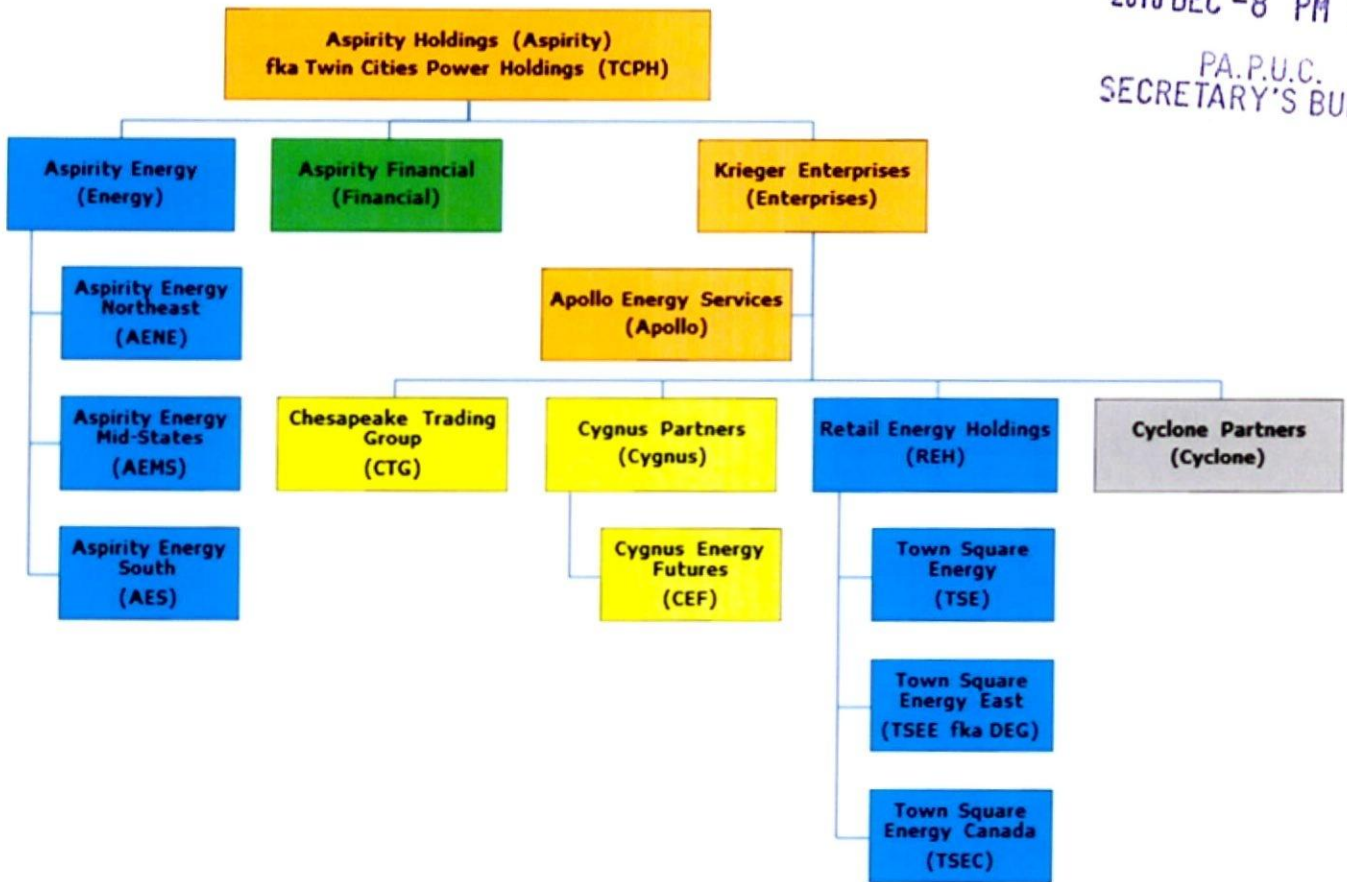

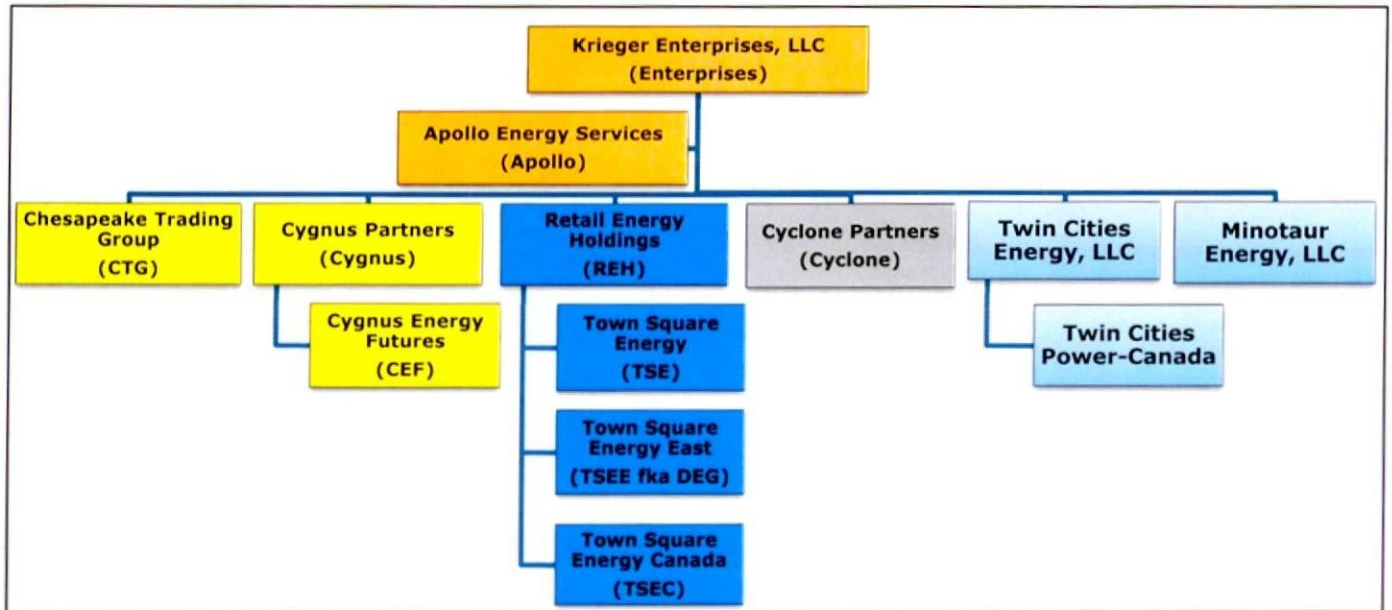

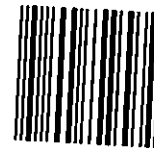
