

COMES NOW, the undersigned incorporator, in compliance with the requirements of Section 204 of the Business Corporation Law, Act of May 5, 1933 (P.L. 364) (15 P.S. §1204), desiring to be incorporated as a business corporation and hereby certifies as follows:

- (1) The name of the corporation is Seger Trucking, Inc.
- (2) The location of the initial registered office of the corporation in this Commonwealth is R. D. 1, Box 457A, Morrisdale, PA 16858 (located on Bigler-Allport Cutoff, approximately 4 miles north from its intersection with U.S. Highway 322).

- (3) The corporation is incorporated under the Business

Corporation Laws of the Commonwealth of Pennsylvania for the following purpose or purposes:

The corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful businesses for which corporations may be organized and incorporated under the Business Corporation Law of the Commonwealth of Pennsylvania, as amended, or any other statute or statutes now or in the future applicable to the corporation.

(4) The term for which the corporation is to exist is perpetual.

(5) The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) shares of common stock, having no par value.

(6) In addition to the one hundred thousand (100,000) shares of common stock, having no par value, which the corporation shall have authority to issue, the Board of Directors of the corporation shall be authorized to fix by a proper resolution the designations, preferences, qualifications, number and other pertinent provisions relative to specific classes or types of preferred stock.

(7) There shall be no cummulative voting in election of the position of Director of the corporation.
