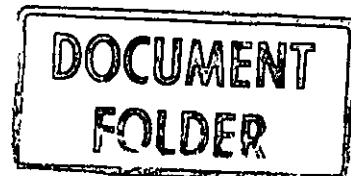
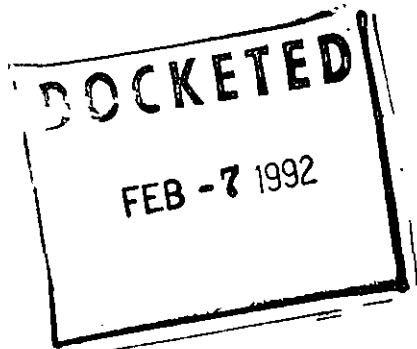
Dear Commission,
