MOTION OF PECO ENERGY COMPANY FOR EXTENSION OF TIME TO ANSWER FORMAL COMPLAINT

PECO Energy Company, ("PECO" or the "Company") hereby files this motion (pursuant to 52 Pa.Code § 5.103) for an extension of time to Answer the Formal Complaint and states the following:

- 1. On November 25, 2015, the Pennsylvania Public Utility Commission's (the "Commission's") Bureau of Investigation and Enforcement ("I&E") served PECO Energy Company ("PECO" or the "Company") with a Formal Complaint including twenty-one (21) counts which, among other things, alleged that PECO failed to prevent Rosemont College's excavation contractor from hitting the Company's gas main while auguring to install a light tower foundation for a newly constructed sports field.
- 2. According to 52 Pa.Code § 5.61(a), PECO has twenty (20) days from the November 25 service date to file its Answer with the Commission's Secretary's Office. Therefore, PECO's Answer to the Formal Complaint is due on December 15, 2015.

- 3. Pursuant to 52 Pa.Code § 1.15 and for good cause shown, the Commission may grant extensions of time for acts that the Pennsylvania Code requires be completed within a specified amount of time.
- 4. Accordingly, PECO respectfully requests an extension of time to answer the Formal Complaint for the following reasons, which serve as the foundation for a showing of good cause to grant such request.
- 5. Specifically, the Formal Complaint raises significant and complex questions regarding the Underground Utility Line Protection Act¹ (Pennsylvania One Call Law). PECO's investigation, for purposes of preparing its Answer, will require additional time to gather and analyze information relevant to the claimed violations. PECO's Answer also will need to incorporate its view of the jurisdictional interplay between the appropriate governing authorities (i.e., the Commission and the Department of Licenses and Inspections).
- 6. PECO requests that the Commission grant its motion, such that the Answer would be due on January 8, 2015.
- 7. Counsel for I&E has informed PECO that it does not oppose PECO's request for an extension until January 8, 2015.
