Dear Ms. Krapf:

This will acknowledge receipt of your letter of November 17, 1992, regarding insurance filings on behalf of Kay Louise Krapf, t/d/b/a Airport Crown Service, and the change of address of your business.

By letter dated April 13, 1992, a notification of suspension was issued by this Commission, which indicated that as of April 15, 1992, the Bodily Injury and Property Damage Liability Insurance (BI&PD) and the Cargo Liability Insurance were either expiring or being cancelled.

On April 16, 1992, the Commission received a Form H from Commerce Protective Insurance Co., indicating that Policy MTC 1035 had been issued, effective April 15, 1992. Because the Commission had not received evidence of BI&PD insurance, an Order to Show Cause, was issued on July 30, 1992.

Since the Commission received no response to the Order to Show Cause, the Certificate of Public Convenience at A-00109689 was cancelled by the Commission effective November 10, 1992.

Since your Certificate of Public Convenience was cancelled, it will be necessary that a petition be filed with the Commission to reinstate the cancelled certificate of public convenience. Should you have any questions concerning this procedure, please contact our Law Bureau at (717) 783-3713.
