
Applicant is seeking increases in hourly rates for Erie County transporting household goods in use for forty (40) miles and less.

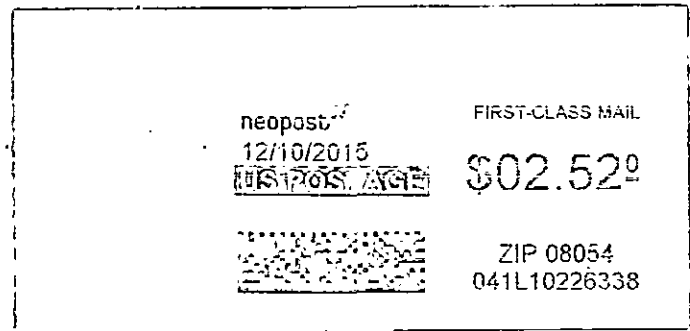
