(1) That the service proposed will be competitive with and detrimental to the existing authorized service of the above named motor carrier.


(2) That there is no public need for the proposed service, nor would the approval of the application for such proposed service be necessary or proper for the service, accomodation, convenience or safety of the public.

ADVERSE IMPACT

A. Duie Pyle, Inc., provides an active, daily service pursuant to Pennsylvania Public Utility Commission authority which duplicates, in part, the authority sought by the instant application. In addition, A. Duie Pyle, Inc. is constantly soliciting additional traffic within the application territory.

The protestant presently derives approximately \$2,000,000 annually in revenue from traffic handled within the scope of this application. A grant of the authority requested would tend to divert both traffic and revenue from A. Duie Pyle, Inc., thereby adversely affecting protestant's overall operation.

DESCRIPTION OF CERTIFICATED RIGHTS



1. Protestant holds authority at A-105585, summarized in Appendix A attached hereto and thereby made a part hereof, in conflict with this application.

2. Protestant performs a specialized service within its territory and, within the scope of its authority, provides an adequate and satisfactory service to the shipping public. Approval of an additional carrier would disrupt protestant's traffic patterns, thereby hindering its ability to render an efficient service to the public and detriment will thereby result to the shipping public in Pennsylvania.

3. If a restrictive amendment will satisfy the interest of the protestant, a proposed restrictive amendment is attached as Appendix B which, if accepted by the Commission, will result in the withdrawal of the protest of the protestant.

4. Pursuant to Section 333(c) of the Public Utility Code (66 Pa.C.S. 333[c]), we hereby request a list of the witnesses expected to testify in the above entitled proceeding, together with the subject matter of their anticipated testimony.

That no right, power or privilege is granted to transport household goods and office furniture in use, new or used household goods, new or used office furniture and commodities in bulk.

That no right, power or privilege is granted to transport shipments between points in the city of Pittsburgh, Allegheny County, and from points in the said city to points within 30 miles by the usually traveled highways of the limits of the said city.

- (i) property obviously could be construed to include petroleum products and/or dry litharge, thus giving applicant at least equal, if not greater authority than the Protestant.
- (ii) even if it is not the intent of the applicant to haul petroleum products at present, if at any time the applicant sells his rights to another company, that company would then be able to haul petroleum products unless a restrictive amendment has been made prior to the transfer.
- (iii)the number of applicants to haul petroleum products has increased substantially during the last several years and have eroded the Protestant's shipper's list which conversely has not increased substantially, thus having an adverse impact.

5. The Protestant's interest would be protected resulting in a withdrawal of the protest if the following amendment were made:







BY THE COMPLISSION:

This matter comes before the Commission on an application filed June 25, 1990. Public notics of the application was given in the Pennsylvania Bulletin of August 4, 1990. One protest was filed but withdrawn, without a restrictive amendment. The now unprotested application is certified to the Commission for its decision without oral hearing. The record consists of verified statements filed by the applicant and one supporting shipper.

Emorgency temporary authority was approved by an order adopted July 26, 1990. Temporary authority was approved by an order adopted October 4, 1990. Both of these grants of authority were for the same shipper but of a lesser geographical territory than sought by this permanent authority application.

Mustang Expediting, Inc. (Mustang or applicant), is a Pennsylvania corporation, with its principal place of business in Aston, Delaware County. Mustang was initially certificated in 1987 and presently operates under seven paragraphs of authority. The applicant maintains a terminal facility at Aston that consists of a warehouse, administrative offices and a fenced, paved parking lot for its vehicles. A fleet of ten trucks, four tractors and thirteen trailers of various types is available to perform the proposed service. Additional equipment will be leased to meet service demands. As a currently operating carrier, Mustang has an intensive safety program for drivers and vehicles in place. As evidence of its financial capacity to assume the burden of the additional operating rights, the applicant reports assots of \$413,855, with liabilities of \$315,741, leaving a shareholders' equity of \$98,114.

John Schuerger, warehouse manager for Tozour Energy Systems, Inc. (Tozour or shipper), submitted a verified statement in support of this application. Tozour maintains a facility in King of Prussia, Montgomery County, where it sells and services heating, ventilating, and air conditioning equipment. The shipper intends to tender five to fifteen shipments, ranging from 100 to 10,000 pounds, per day to the applicant. Primarily, service will require closed vans with lift gates but occasionally flat-bed trailers, unloaded by crane, will be needed. (a) Nature of protestant's interest

The applicant seeks the following authority,

"So as to permit the transportation of property between points in the counties of Chester, Montgomery, Bucks and Lancaster. Application for temporary authority has been filed at A-00109534, Folder 1, AM-A, seeking the right cited above."

Courier Unlimited, Inc. possesses authority from the PA PUC which enables it to transport parcels and packages, no one parcel or package to exceed one hundred (100) pounds in weight, between points in Pennsylvania within 125 miles of the township of Upper Providence, Montgomery County (A-00097535, F.1, AM-D). In addition, protestant holds authority for like commodities (A-00097535, F.1, Am-E) which enables protestant to perform transportation (inter alia) of parcels and packages, each not exceeding 100 pounds in weight, from points within 125 miles of the township of Upper Providence to points beyond 125 miles of Upper Providence and vice versa. Such application also granted authority between points in that area of Pennsylvania beyond 125 miles of Upper Providence Township, subject to some restrictions. The authority sought which duplicates that held by protestant is as described above. See adverse impact statement.

. .

Protestant is presently providing a complete service within the scope of protestant's authority which includes all of the area involved in applicant's broad application. Effectively, protestant has territorial authority between points in Pennsylvania with some exceptions not here relevant.

With regard to applicant's request for **Temporary Authority**, let us first analyze the support given or not given for the Temporary Authority Application for the transportation of property between points in the counties of Chester, Montgomery, Bucks and Lancaster.

Submitted with the application for Temporary Authority are twelve (12) one-sentence letters of support. Such 12 one-sentences may be paraphrased thusly:

> "We support the emergency grant of authority in the following counties Montgomery Chester Delaware Bucks Lancaster."

The county of Delaware does not appear in the PA Bulletin publication notice of the application and therefore is not part of the authority sought in the permanent and temporary authority applications. Of the twelve (12) alleged supporting statements, all twelve (12) give <u>no</u> description of any commodity to be shipped; there are <u>no</u> origin point or points of any shipments; <u>no</u> representative destination points of any shipments; <u>no</u> expression of need for motor carrier transportation; <u>no</u> frequency of any transportation now utilized; <u>no</u> allegation of any unsatisfactory service.

. .

Seldom has the protestant seen temporary authority supporting shipper statements so void of any basic and fundamental information. There is absolutely no factual or legal basis presented upon which a grant of temporary authority could properly be granted.

Thus, standing upon its own merits, the applicant has failed to make out even a prima facie case of need for the proposed property temporary authority and such application should be denied.

The protestant **Courier Unlimited**, **Inc.** holds authority to transport packages (100 lbs or less) effectively between points in Pennsylvania, with certain restrictions. See copies of authority attached. As here pertinent, it transports between points in Chester, Montgomery, Bucks and Lancaster Counties; it operates terminals at Oaks with 14 vehicles and 30 employees of which 22 are drivers.

Courier Unlimited, Inc. is able and willing to perform transportation for any shippers requiring transportation of parcels and packages between points in the four counties sought by applicant within the scope of its weight limitations.

(b) Adverse Impact

. .

There is no need for additional authority as sought by applicant which would conflict with that held by protestant. The service of protestant within the scope of its pertinent authorities meets any public need. A grant of authority to applicant which would duplicate any of the areas of transportation activity of protestant, would impair the operations of protestant to the extent, on balance, that it would be adverse to the public interest; there would be an adverse public impact by a grant of the application.

Protestant challenges the fitness of applicant to conduct the proposed service; there is no need for the authority.

There are 26 individual shippers supporting this application which represent a wide variety of business endeavors and an equally wide variety of commodities. There are eight banks, three manufacturers, three advertising egencies, a toy distributor, three printing companies, a healthcare organizaegencies, a toy distributor, three printing companies, a healthcare organization and a law firm among the shippers, all professing a need for expedited transportation services. A wide range of commodities are involved, such as product samples, payroll documents, artwork, graphic designs, brochures, video tape, promotional material, medical records, banking documents, etc. The property description proposed by the applicant is well supported and justified.

There are 35 individual counties embraced within the proposed 125 airline mile radius of Upper Providence Township, Montgomery County. Collectively, the shippers have demonstrated a need for service either to, from or between points in each county. The very nature of the service dictates that in a majority of instances, those shipments moving from a shipper's place of business to a branch location or other customers, will in turn, result in shipments back to the shipper's place of business. This matter comes before the Commission on an application filed June 25, 1990. Public notice of the application was given in the Pennsylvania Bulletin of August 4, 1990. One protest was filed but withdrawn, without a restrictive amendment. The now unprotested application is certified to the Commission for its decision without oral hearing. The record consists of verified statements filed by the applicant and one supporting shipper.

Emergency temporary authority was approved by an order adopted July 26, 1990. Temporary authority was approved by an order adopted October 4, 1990. Both of these grants of authority were for the same shipper but of a lesser geographical territory than sought by this permanent authority application.

Mustang Expediting, Inc. (Mustang or applicant), is a Pennsylvania corporation, with its principal place of business in Aston, Delaware County. Mustang was initially certificated in 1987 and presently operates under seven paragraphs of authority. The applicant maintains a terminal facility at Aston that consists of a warehouse, administrative offices and a fenced, paved parking lot for its vehicles. A fleet of ten trucks, four tractors and thirteen trailers of various types is available to perform the proposed service. Additional equipment will be leased to meet service demands. As a currently operating carrier, Mustang has an intensive safety program for drivers and vehicles in place. As evidence of its financial capacity to assume the burden of the additional operating rights, the applicant reports assets of \$413,855, with liabilities of \$315,741, leaving a shareholders' equity of \$98,114.

John Schuerger, warehouse manager for Tozour Energy Systems, Inc. (Tozour or shipper), submitted a verified statement in support of this application. Tozour maintains a facility in King of Prussia, Montgomery County, where it sells and services heating, ventilating, and sir conditioning equipment. The shipper intends to tender five to fifteen shipments, ranging from 100 to 10,000 pounds, per day to the applicant. Primarily, service will require closed vans with lift gates but occasionally flat-bed trailers, unloaded by crane, will be needed. Both inbound and outbound service is required and movements direct from suppliers to customers. Tozour has used Mustang for its transportation needs in Delaware and New Jersey and is satisfied with their service and full supports the grant of authority proposed by this application.





Forty seven supporting shippers submitted standardized verified statements, stating a need for the transportation of various types of property, no single package, parcel or item of property to exceed one hundred pounds, between points in Pennsylvania. The basic evidence of each witness in terms or origins and destinations, are summarized below.

Edwin C. Koontz, manager of human resources for Clinical Pathology Facility, submitted a verified statement in support of the amended application. This shipper manufactures devices for blood and urine testing at a facility in Philadelphia. Representative destinations include Allentown, Bethlehem, Erie, Harrisburg, Scranton, State College and Wilkes-Barre. It expects to use the applicant's service for approximately fifty shipments per month.

Kevin F. Brett, industrial insurance specialist for Damon Chemical, submitted a verified statement in support of the amended application. This shipper operates a medical analysis facility in Trevose, Bucks County. It expects to use the applicant's service for approximately ten shipments per month between its facility and customers located in Allentown, Camp Hill, Harrisburg, Lancaster, Norristown, Philadelphia and Pittsburgh.

Patricia Moore, manager of Town and Country, submitted a verified statement in support of the amended application. This shipper is involved in the automotive rental business, with facilities in Philadelphia, Germantown and Bala Cynwyd. It expects to use the applicant's service for approximately eight shipments per month between its facilities.

This shipper is involved in the sale of automobile parts and accessories, with a facility of Elkins Park, Montgomery County. Representative destinations include points in the counties of Montgomery and Philadelphia. It expects to use the applicant's service for approximately four shipments per month.

Jules Stein, manager of Sabott Beauty Supply, submitted a verified statement in support of the amended application. This shipper is involved in the wholesale distribution of beauty supplies, with a facility in Philadelphia. Representative destinations include various points in the counties of Bucks, Chester, Delaware, Montgomery and Philadelphia. It expects to use the applicant's service for approximately twenty-five shipments per month.

DISCUSSION AND FINDINGS

The applicant is a currently certificated carrier, operating under a limited commodity statewide authority. It has a large fleet (225 vehicles) and seven facilities (with two more to be added in the future) in the state. Its balance sheet and income statement indicate that it has the financial ability to begin the additional proposed service. It has demonstrated no propensity to operate in an unsafe or illegal manner. USCCS has thus demonstrated that it is fit to provide the proposed service, pursuant to 52 Pa. Code §41.14(b).

Forty-seven witnesses have submitted support statements indicative of a public demand or need for the proposed service, as required by 52 Pa. Code §41.14(a). Whether this is sufficient evidence must be judged in terms of the breadth of the operating authority and the commodity description. Application of Bluebird Coach Lines, Inc., A-00088807, F. 2, Am-K (order adopted March 15, 1990). In this case, the geographical area is the entire state, subject to certain restrictions (see especially restrictions (a), (b) and (c) in the caption). The commodity description, "property", is also broad even with its restrictions (see especially restrictions (d), (f) and (g)). The limiting factor of this application, however, is the one hundred pound weight limit. Taking that factor into consideration, we must view the proposed right as rather limited. Considering the variety of origins and destinations, which cover most of the population centers of the state, we believe that the applicant's forty-seven witnesses do represent a crosssection of the shipping public for this type of service and, as such, is evidence of a public demand or need for the proposed service. We also note that the applicant presently holds statewide authority for transporting various financial and business documents and media. The extension into the small shipment business will allow for a more efficient use of the applicant's fleet and such efficiency will ultimately be to the public's benefit.

Several of the supporting witnesses testified to a need for some service that would not be permitted under the restrictions to the proposed right. We will, therefore, caution the applicant to carefully instruct its sales staff and drivers in the limits of its new operating authority, and to distinguish it from its initial right, so that no problems arise as to the commodities, geographical area, or shippers that may be served.

After a complete review of the record before us, we find:

1. That the applicant has shown that there is a public need for the proposed service, as amended.

2. That the applicant possesses the necessary equipment, experience, and financial capacity to perform the proposed service, as amended.

3. That approval of the application, as amended, is necessary for the accommodation and convenience of the public; THEREFORE,

IT IS ORDERED: That the application, as amended, be and is hereby approved and that the certificate issued to the applicant on October 9, 1985, be amended to include the following right:

To transport, as a Class D carrier, parcels, packages and items of property, no single parcel, package or item of property to exceed one hundred (100) pounds in weight, between points in Pennsylvania;

subject to the following conditions:


- (a) That no right, power or privilege is granted to provide service to, from or between points in the counties of Crawford, Erie, Mercer and Venango;
- (b) That no right, power or privilege is granted to provide service between points in the city of Pittsburgh, Allegheny County;
- (c) That no right, power or privilege is granted to provide service from points in the city of Pittsburgh, Allegheny County, to points in Pennsylvania within thirty (30) miles by the usually traveled highways of the City-County Building in said city, except where the transportation involves the carrying of the goods of more than one consignor on the truck at one time;
- (d) That no right, power or privilege is granted to transport human laboratory specimens and clinical laboratory instruments, supplies and reports between points in the counties of Allegheny, Armstrong, Lawrence, Butler, Washington, Westmoreland, Greene, Indiana, Mercer, Somerset, Bedford and Beaver;
- (e) That no right, power or privilege is granted to provide service for Victaulic Company of America, Inc.; Atlantic Track &

Turnout Co.; Union Camp Corporation; John Konopka & Sons; S.I. Handling Systems, Inc.; Atlantic States Cast Iron Pipe Co.; and American Metallurgical Products Company;

- (f) That no right, power or privilege is granted to transport garments and wearing apparel on hangers and garments, wearing apparel and the materials, equipment and supplies used in the manufacture and sale of garments and wearing apparel, when moving in the same vehicles as garments and wearing apparel on hangers;
- (g) That no right, power or privilege is granted to transport bound and unbound printed paper and partially printed paper and printing orders, instructions and materials for commercial printers and supplies to commercial printers to or from points in the counties of Berks, Cumberland, Dauphin, Lancaster, Lebanon and York;
- (h) That no right, power or privilege is granted to provide service for hospitals or the American Red Cross between points in the city of Wilkes-Barre, Luzerne County, and within an airline distance of 30 statute miles of the limits of said city, and from points in said territory to points within an airline distance of 150 statute miles of the limits of said city, and vice versa;

IT IS FURTHER ORDERED: That the applicant shall not engage in any transportation granted herein until it shall have complied with the requirements of the Pennsylvania Public Utility Code and the rules and regulations of the Commission relative to the filing and acceptance of a tariff establishing just and reasonable rates.

IT IS FURTHER ORDERED: That the authority granted herein to the extent that it duplicates authority now held by or subsequently granted to the applicant, shall not be construed as conferring more than one operating right. IT IS FURTHER ORDERED: That in the event said applicant has not, on or before sixty (60) days from the date of the service of this order, complied with the requirements hereinbefore set forth, the application shall be dismissed without further proceedings.






