

REPLY OF JOYCO INC t/d/b/a RAPID DELIVERY TO MOTION OF JAMOUR INC. TO STRIKE ITS REPLY TO JAMOUR'S MOTION FOR RELIEF FROM STAY

Protestant Jamour, Inc. t/d/b/a Quick Courier Service ("Quick") has filed a motion seeking to strike the reply which was filed by applicant Joyco, Inc. t/d/b/a Rapid Delivery ("Rapid Delivery") to Quick's motion which seeks a relief from a stay and the issuance of a cease and desist order precluding Rapid from continuing its current service to the extent to which it is arguably beyond that permitted by its certificate while it amends its application currently being heard.

In its initial reply to the Quick initial motion seeking a cease and desist order, as well as in the Reply which the instant motion seeks to strike, Rapid Delivery has pointed out that the issuance of a cease and desist order is improper because (i) the Administrative Law Judge has no authority to do so when the only matter before him is an application, (ii) even if such an order could be issued in such an application proceeding, it would not be justified here because the operations of Rapid Delivery do not under law justify a rejection of its application, let alone a cease



and desist order, and (iii) even if the issuance of a cease and desist order was authorized in an application proceeding, and even if the facts initially elicited justified the issuance of such an order, no such order could be considered until a full due process hearing was afforded applicant-respondent, and no such hearing has here been afforded, in view of the ordered stay.

As to Quick's current motion to strike, it can readily be disposed of by making two simple points:

- 1. Rapid Delivery's Reply was timely filed. By telephone conference call June 29, 1992, Judge Kranzel allowed Rapid Delivery tan days to file a Reply. Counsel for Rapid Delivery filed the Reply July 10, after having notified Judge Kranzel's office the previous day that a brief additional time would be required. Such filing on the 11th day, after notification on the 10th day that the filing would be delayed one or two days should be properly considered timely, consistent with Commission practice and in effectuating the mandate that the Commission's rules be liberally construed. If a filing one day late requires a waiver of the 10 day rule, it is properly granted.
- 2. Even if Rapid Delivery's Reply is ignored as untimely filed, there is still no basis for the issuance of a cease and desist order. It is still beyond the authority of an Administrative Law Judge's to whom the only matter referred was an application, not a Complaint, it is still unjustified by the applicant-respondent's conduct, and it is still improper absent the affording to applicant-respondent of a full due process hearing.

Thus, the Quick Motion to Strike should be dismissed and denied. But even were the Quick Motion to Strike to be granted, the underlying Quick Motion for the lifting of a stay and the issuance of a cease and desist order should be dismissed and denied on the basis of (i) the law, (ii) as pointed out in Rapid Delivery's timely Reply to Quick's initial Motion for a Cease and Desist Order which was effectively precluded by the Stay, and which Quick currently seeks to renew.






