

TO THE HONORABLE COMMISSION:


AND NOW comes Respondent, Duquesne Light Company, by and through its attorneys, Tucker Arensberg, P.C., and files this Motion for Continuance of Hearing in accordance with Commission regulation 52 Pa. Code § 1.15 (b).

1. The above-captioned Formal Complaint was filed on or about November 3, 2015, and has recently been scheduled for an Initial Telephonic Hearing on Wednesday, January 20, 2016, at 10:00 a.m.
2. Duquesne Light has a scheduling conflict with the date and time of the hearing, as it has a mandatory employee conference scheduled to which certain witnesses for this matter must attend. Accordingly, counsel for Duquesne Light respectfully requests a two-week continuance of the hearing in this matter.


