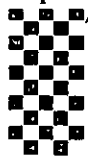



This is in response to your letter dated January 11, 2007, in which you requested a change in name. - A copy of the amended articles of incorporation or revised partnership agreement, if applicable, or other proper evidence of the name change.
- The names of the owners of the stock and the distribution of shares
- The names of the officers or directors of the corporation
- A statement that there has been no change in the ownership or control of the company

Upon submission of the above items, the Commission will endorse the existing certificate in the new name at the existing docket number. In accordance with Title 52 § 3.381(a)(6)(i)(B), within thirty (30) days of the Commission's endorsement, the motor carrier shall effect the change in name on its insurance filings (Form E and Form H or cargo waiver if applicable) and tariff filing, if applicable, with the Commission.



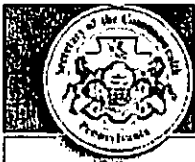


