In response to the requests contained in your August 8, 2007 letter, the 1328 shares were from existing treasury stock of L&J Transportation Companies, Inc. Mr. Fry, the only original shareholder, already owned 9000 shares. He received 611 from the corporation, Sandra Shaeffer received 611 from the corporation, and Rodger Caramanica received 136 shares from the corporation. In addition, both James B. Fry and Sandra Shaeffer each bought from the corporation an additional 1500 shares.
