Enclosed for filing is X5 OpCo LLC's ("X5 OpCo") *Application for Approval to Offer, Render, Furnish or Supply Telecommunications Services to the Public in the Commonwealth of Pennsylvania as Competitive Local Exchange Carrier* ("Application") and supporting documents. A \$250.00 filing fee payable to the "Commonwealth of Pennsylvania" is also enclosed.

By this Application, X5 OpCo seeks expanded operating authority to provide competitive local exchange services¹ in conjunction with the Company's and CornerStone Telephone Company's *Joint Application for Approval of a General Rule Transaction*, submitted under separate transmittal.

Pursuant to 52 Pa. Code §§5.362 and 5.423, X5 OpCo respectfully requests that the Commission treat all financial data submitted as part of this Application as confidential and proprietary information, not to be released to the public. Accordingly, X5 OpCo's financial information is filed under seal as **confidential Exhibit C**. Redacted copies of X5 OpCo's Application have been served on the required parties in accordance with the attached Certificate of Service.

X5 OpCo also respectfully requests a waiver of the requirement to contact the appropriate 911 Coordinator(s), prior to the filing of its Application, regarding the provisioning of emergency 911 in each PSAP where service is to be provided. X5 OpCo is contemporaneously filing an Application seeking approval for the transfer of assets and customers from Cornerstone Telephone Company, LLC ("Cornerstone"), a certificated CLEC in Pennsylvania. Because of this pending transaction, and in order to avoid potential confusion, X5 OpCo respectfully proposes collaboratively contacting the appropriate 911 coordinators with Cornerstone upon approval of the asset transfer transaction.
