CERTIFICATE OF SATISFACTION

1. Complainants are Richard and Sandra Meals.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as “PPL Electric”).
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainants, Richard and Sandra Meals (“Complainants”), and Respondent, PPL Electric Utilities Corporation (“Respondent”), agree that Respondent will apply a credit of twenty percent (25%) of their total account balance, or Three Hundred Twenty Dollars and Four Cents (\$320.04) to Complainants’ account. Complainants and Respondent further agree that after Respondent applies the aforementioned credit, Complainants’ account balance will be reduced from One Thousand Two Hundred Sixty-Six Dollars and Four Cents (\$1,266.04) to Nine Hundred Forty-Six Dollars (\$946.00), which Complainants will pay-off over the course of six (6) months in equal monthly installments. Complainants and Respondent further agree that Complainants will pay his regular monthly bill plus \$157.67 per month toward arrearages, until all arrearages are paid in full, beginning with Complainants’ January 2016 due date.

(b) Complainants withdraw their Complaint.

5. Respondent, PPL Electric hereby notifies Complainants of the filing of this Certificate of Satisfaction, and that if Complainants object or disagree with the terms of the Certificate of Satisfaction, Complainants must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
