Please find enclosed evidence of the \$10,000 bond required for the subject Electricity and Natural Gas Supplier (broker/marketer) licenses for calendar year 2016. Except for my signature this is a copy of the bond due to an error by the bonding company on the original issue of the first page which discovered too late to correct in time to have the corrected original to the PUC on 12/31/15. There is however no question that bond coverage for 2016 is in place as of the date noted on the copy. The corrected original is being overnighted to the PUC on 12/31/15.

We continue to accelerate our application for bonding each year to insure strict compliance with PUC requirements; however surety requirements and timing continue to be unpredictable. We apologize for the delay in original paperwork.

Once again, we respectfully request that the Commission consider dropping this requirement for brokerage firms such as ours since we are an out of state broker/marketer and as such do not and will never have state tax liability in the Commonwealth of Pennsylvania.

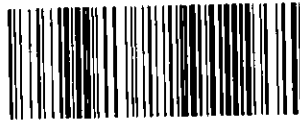
