
Ms. Rosemary Chiavetta:

I am a writing to you in regards to the bridge spanning the railroad tracks on Sunset Road in La Plume Township (SR 4009). The fate of the bridge had been discussed and decided in cases P-2011-2241780 and C-2011-2237486.

My family and I are the other residents of the road who are affected by the bridge and the hearing was held and adjudicated without our knowledge. It is our understanding that through the hearing the bridge had been scheduled to be torn down in the past and is recently in discussion to be torn down in April. As the other members of the road who use the bridge, the removal would be a great inconvenience and we do not feel it is the most amicable solution.

By tearing down the bridge, our only other way to leave and return to our home would be to go through a narrow, non-paved road which becomes treacherous during the winter months and during some heavy rain storms. Emergency vehicles would also have a very difficult time accessing our home through the back road, even during fair weather, due its minimal size. Further, my brother is a student in the Abington Heights school district and his transportation through the district uses the bridge to transport him to school. Finally, our driveway is designed in a way to be accessed from the direction of the bridge, not from the narrow back road, as we do not use it especially during the winter months.

We wish for reconsideration and for an opportunity to voice our view that the bridge is as asset to the use of our home and to be a part of the decision. Thank you for your time and consideration, we hope to hear from you soon.


