

4. AUTHORITY SOUGHT

To transport, as a common carrier, household goods in use, between points in the counties of Philadelphia, Bucks, Delaware, Montgomery and Chester, and from points in said counties to points in Pennsylvania and vice versa;

with the aforesaid right subject to the following conditions:

1. That no right, power or privilege is granted to perform service from or to points in the county of Centre and those points in other counties lying within an airline distance of twelve (12) miles of the limits of the borough of State College, Centre County; and
2. That no right, power or privilege is granted to perform service for Avtex Fibers Lewiston, Inc., Lewiston Hospital, Geisinger Medical Group, and the Central Pennsylvania Conference of the United Methodist Church, from or to points in the county of Mifflin.

See Applicant's Letter Amendment of July 12, 1995, attached hereto as Exhibit "C" and Stipulation by and between David M. Krmptich, Inc. and Hoy Transfer, Inc., dated October 24, 1995 and attached hereto as Exhibit "D".

5. GENERAL SCOPE OF CURRENTLY AUTHORIZED OPERATIONS

David M. Krmptich, Inc. currently possesses a license from the Pennsylvania Public Utility Commission to operate as a motor common carrier of property in the Commonwealth of Pennsylvania. A copy of the Certificate of Authority in this regard is attached hereto as Exhibit "E".

6. DUPLICATING AUTHORITY WHICH WILL RESULT FROM GRANT OF AUTHORITY

Approval of the authority sought by the Applicant will not result in an overlap of rights currently held.

7. **TERMINAL FACILITIES AND COMMUNICATIONS NETWORK**

The Applicant's vehicle will be stored, dispatched and repaired in the City and County of Philadelphia. Specifically, the Applicant's vehicle will be stored and dispatched from the Applicant's facility located at 3352 Wiehle Street, Philadelphia, PA 19129. The Applicant's vehicle will be serviced and/or repaired under contract by Bentley Truck Service, Inc., 3540 South Lawrence Street, Philadelphia, PA 19148.

The Applicant's communications network consists of both cellular and land line telephones. The Applicant's vehicle is dispatched via cellular telephone and cellular telephone equipment is maintained on-board the Applicant's vehicle. Additionally, the Applicant's facility at 3352 Wiehle Street, Philadelphia, PA 19129, maintains one land telephone line.

8. **EQUIPMENT**

The Applicant's equipment consists of one (1) 1990, 16', 6½ ton, diesel, Isuzu straight truck which is owned and operated solely by the corporation, David M. Krmpotich, Inc.

9. **SAFETY PROGRAMS**

The Applicant's vehicle is operated solely by David M. Krmpotich, President of David M. Krmpotich, Inc. Mr. Krmpotich maintains a Class "B" Commercial Drivers License issued by the Commonwealth of Pennsylvania (License No. 20-522-188). Prior to operation each day, the Applicant's vehicle is fully and completely inspected by the operator as follows: (i) oil checked; (ii) tires checked; (iii) brakes checked; and (iv) vehicle checked for visual impairments.

In order to insure proper vehicle maintenance and safe operation of the vehicle, the Applicant's equipment is serviced and/or repaired under contract by Bentley Truck Services, Inc., 3540 South Lawrence Street, Philadelphia, PA 19148. Specifically, the truck is enrolled in a preventive maintenance

program wherein the vehicle is checked every 6,000 miles pursuant to the manufacturer's recommendations. During such inspections the following parts and/or systems are checked, inspected and/or changed: oil, brakes, wheels, lights, tires, etc. (See June 6, 1996 correspondence from Bentley Truck Services, Inc., attached hereto as Exhibit "F").

Importantly, by correspondence of December 18, 1995, the Applicant was notified by the Public Utility Commission that the Company had received a "satisfactory" rating following a November 20, 1995 safety fitness review. A copy of the December 18, 1995 correspondence as well as the November 20, 1995 Safety Fitness Review Report are attached hereto as Exhibit "G".

11. TYPE OF SERVICE OFFERED

David M. Krmpotich, Inc. offers the following freight services: (i) truckload; (ii) less than truckload; (iii) multiple delivery; (iv) same day; and (v) specialized handling.

12. FINANCIAL DATA

Attached hereto as Exhibit "I" is a copy of Applicant's Statement of Assets and Liabilities Arising from Cash Transactions, dated December 31, 1995. The Applicant also makes reference to its most recent Statement of Operating Revenues for General Assessment attached hereto as Exhibit "J".

13. OTHER INFORMATION DEEMED PERTINENT

David M. Krmpotich, Inc. has held a license from the Pennsylvania Public Utility Commission to operate as a motor common carrier of property in the Commonwealth of Pennsylvania since July 20, 1995. From July 20, 1995 to the present, the Applicant has operated in accordance with the above-referenced license on a continual basis and has maintained a spotless record of high-quality service to the citizens of the Commonwealth of Pennsylvania. Since July 20, 1995, David M. Krmpotich, Inc. has received no customer complaints regarding services provided, and no traffic citations from any law enforcement organization relative to the operation of its vehicle. Importantly, the Applicant has received no citations relative to violations of Pennsylvania Public Utility Commission Regulations. In this regard, it is important to note that the Applicant's facility and equipment underwent a safety inspection by Public Utility Commission Officers on November 20, 1995 and received a satisfactory rating.

With regard to experience, the Applicant, as noted above, has successfully operated as a motor common carrier of property in the Commonwealth of Pennsylvania since July 20, 1995. Moreover, David M. Krmpotich, President of the Applicant, brings with him fifteen (15) years of experience in the heavy

construction industry. Specifically, Mr. Krmpotich supervised and/or assisted with the transportation, lifting and moving of heavy construction materials (for example, the lifting and moving of 2½ ton pipe sections during the construction of the Vine Street Expressway (Route 676) in Philadelphia).

With regard to the integrity and work ethic which is essential to operation of a dependable and responsible moving business, it is interesting to note that Mr. Krmpotich represented the United States in international and Olympic rowing competition over the course of twelve (12) years. During that time Mr. Krmpotich earned an Olympic Silver Medal at the 1988 Olympic games held in Seoul, South Korea. He also earned a Bronze Medal at the 1986 World Championships held in Nottingham, England, and a Gold Medal at the 1986 Goodwill Games, held in the former Soviet Union. Additionally, since 1985, Mr. Krmpotich has served as the Head Rowing Coach at Monsignor Bonner High School located in Drexel Hill, PA. In this capacity, Mr. Krmpotich is responsible for the safety and well being of sixty (60) young men as they are instructed and trained in the sport of rowing.

Based on the above, as well as the Verified Statements in Support of the Application, which are incorporated by reference herein, the Applicant avers that it is well qualified to operate a dependable and responsible moving business with the integrity and work ethic which the Citizens of the Commonwealth of Pennsylvania deserve. The Applicant also avers that approval of the instant application will “serve a useful public purpose, responsive to a public demand or need,” that the Applicant possesses the technical and financial ability to provide the proposed service, and that the Applicant will operate safely and legally.
