Recently this Commission received information that you are transporting property for compensation between points in the Commonwealth of Pennsylvania, under the trade name of "Hercules Movers" instead of your Application/Certificate trade name of "John K. Kane."

If this information is correct, it would be necessary to have your certificate of public convenience amended to reflect such a trade name change.

The correct company name you should be using on your vehicles is "John K. Kane." Failure to display correct identification markings on your motor vehicles may subject your company to penalties, which may include fines of \$1,000.00 per violation.
