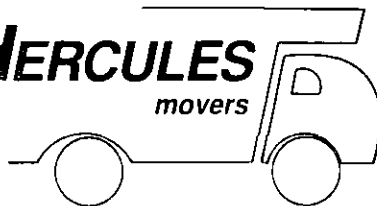

Dear Mr. Alford:

I have only recently been informed on March 16, 1993 that my PUC license (A-00109368) was cancelled. Unfortunately, I was not personally notified by the PUC, so I could not take more immediate action. I am writing this letter to resolve this issue as soon as possible, and reinstate my license.

All payments to the PUC have been sent on time. The assessment payment (check # 2049) was mailed on Dec. 11, 1992, and was received by Dec. 21, 1992. I followed up via a phone conversation with Louis E. Miller, Assessment Specialist, on Dec. 21, 1992, at 10:28 AM. During our 11 minute conversation, he confirmed that he received the check on time. I recently had another conversation with Mr. Miller verifying this fact. He assured me that he had received the payment by Dec. 21, 1992.

I will contact you shortly, following the receipt of this letter, to discuss how to resolve this situation. I look forward to speaking with you and hope that you can help resolve this conflict as soon as possible. I am attaching copies of the check and my phone bill for the dates in question.
