


#### 2. IDENTITY AND QUALIFICATIONS OF WITNESS

My name is Marvin H. Weiner and I am the Chief Executive Officer and owner of Mt. Airy Cold Storage. Chambersburg Cold Storage is a newly formed Company and I am also the Chief Executive Officer and owner of that Company. I have nineteen years in cold storage warehousing and have been actively involved in all phases of transportation logistics.

I am also Chief Executive Officer and owner of Cryo-Trans, Inc. Cryo-Trans, Inc. holds a patent for a new state-of-the-art cryogenically refrigerated transportation system. This Company is lessor of more than three hundred cryogenically refrigerated rail cars to major frozen food processors for their long term use throughout the United States.

I have also served as an officer of Florence Beef Company and my 20 years experience with that Company included responsibility for transportation matters.





#### 3. GENERAL DESCRIPTION OF SHIPPER'S OPERATIONS

Chambersburg Cold Storage has been formed to operate as a public cold storage warehouse. All products shipped into and out of the warehouse require temperature controlled equipment. Temperature range required for these products is from plus 45 degrees Fahrenheit to minus 10 degrees Fahrenheit.

Chambersburg Cold Storage is planning to construct a new state-of-the-art public cold storage facility in the Chambers 5 Industrial Park, adjacent to Exit 5 of Interstate 81. This multimillion dollar project will be served by both the CSXT and Conrail Railroads. The facility will consist of 112,000 square foot "minus 10 degree" freezer box, a ten door refrigerated truck dock, a six door refrigerated "transload" truck dock, and a refrigerated rail receiving dock capable of unloading seven jumbo rail cars simultaneously. The total facility will exceed 150,000 square feet and is capable of future expansion to 285,000 square feet.

The planned facility will be totally racked and is designed for approximately 14,000 pallet positions of frozen food. The warehouse will employ approximately 40 people. This cold storage facility will also feature computerized inventory control, computerized refrigeration control and computerized security.

Chambersburg Cold Storage will primarily receive, store and redistribute frozen food products from the west coast to markets throughout the eastern seaboard of the United States.
