I am in receipt of the foremost referenced Complaint against my insured. I sincerely apologize for the misunderstanding between my underwriter and myself regarding the PUC filing for my client Ace Limousine, which led the ARI's late filing. Please forgive us. I have taken care of the filing as soon as I learned about it yesterday afternoon. A copy of the filing to the Commission made sent yesterday evening via NOR system, by the insurance company is attached.

My underwriter only filed the federal BMC-91X, as my request for the PUC filing was not clear. However, I have contacted my underwriter at ARI Mutual yesterday afternoon and he has immediately sent out the requested Form E, effective 9/29/15. The prior policy with Lancer Insurance was subsequently cancelled after the new policy went into effect. At no point, was my client's limousine company uninsured.

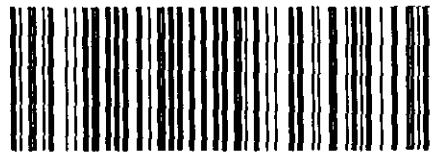

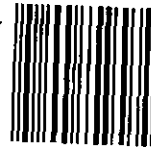
