Your request for an extension of the time period, to comply with the Pennsylvania Public Utility Commission's requirements to submit to a safety fitness review, from 180 days to one year has been received and approved. In accordance with that request you must submit to the review prior to March 20, 1996.

If you have already obtained your certificate of public convenience, you must continue to maintain evidence of insurance with the Commission.

You must notify the Commission's Motor Carrier Enforcement Division, in writing, of the date on which you plan to begin motor carrier operations. In addition, unless you have previously done so, you will also be required to show evidence of insurance by filing Form E, and if necessary Form H, prior to commencing transportation operations.


