Addendum to Articles of Incorporation

CORPORATION

The Shareholders (or Directors at the direction of the Shareholders or Incorporators) may, by adoption of an appropriate By-Law or By-Law Amendment, provide for mandatory dividends or other distributions to all shareholders of defined percentages of the distributable net income of the Corporation arising in any year in which the Corporation is taxed as an "S" or equivalent corporation under the laws of the United States of America, the Commonwealth of Pennsylvania, or both. In the event of the adoption of such a By-Law or By-Law Amendment, the mandated dividend or other distribution shall be enforceable by each shareholder in accord with the provisions of Section 1521(b)(3) of the Business Corporation Law of 1988 of the Commonwealth of Pennsylvania.
