Duquesne Light Company's ("Duquesne Light" or the "Company") Rider No. 1 – Retail Market Enhancement ("RME") Surcharge became effective with a zero rate for all customer classes on June 1, 2015, pursuant to the Pennsylvania Public Utility Commission's Order issued at Docket Number P-2014-2418242.

The RME Surcharge was zero for the reconciliation period of June 1, 2015, (inception of the rate) through December 31, 2015, and had no associated revenues or expenses. There is, therefore, no over or under collection for this initial reconciliation year of the surcharge.
