
The proposed over forty (40) mile rates are being increased for the transportation of household goods in use.



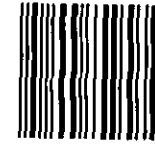

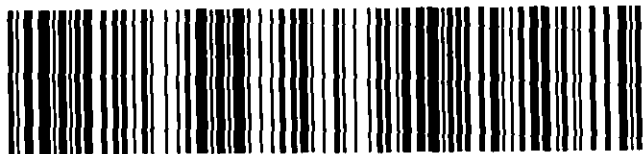
