You may want to operate prior to filing permanent proof of insurance. Temporary proof of insurance consists of two elements. You need to file:

For bodily injury and property damage (BIPD) only (submit one)

- a. A copy of the insurance identification card for vehicles registered in Pennsylvania; **or**
- b. A copy of the declaration page of the insurance policy; **or**
- c. A copy of a valid binder of insurance; **or**
- d. A copy of valid application for insurance to the Pennsylvania Automobile Insurance Plan.

- and -

For cargo insurance (submit one)

- a. A copy of the declaration page of the insurance policy; **or**
- b. A copy of a valid binder of insurance; **or**
- c. A copy of a cargo waiver

If you have not previously submitted a copy of current satisfactory safety rating from the U.S. Department of Transportation or another state with safety regulations comparable to Pennsylvania, you must demonstrate safety fitness by completing a Safety Fitness Review which will be scheduled by a PUC enforcement officer within 180 days of the date this letter is entered.
