Barnes Professional Limousine Service LLC (Respondent) has paid the amount sought by the Bureau of Investigation and Enforcement (I&E) of the Pennsylvania Public Utility Commission (Commission) in order to resolve the above-docketed proceeding.

On February 8, 2016, the Commission received payment in the amount of \$500, which was the reduced civil penalty agreed upon between I&E and Respondent to resolve the complaint alleging Respondent's violations of the Public Utility Code and the Commission's regulations. 
