In compliance with the requirements of the applicable provisions relating to articles of merger, the undersigned, desiring to effect a merger, hereby state that:

1. The name of the corporation surviving the merger is:

Philadelphia Area Independent Schools Health Insurance Group

2. The surviving corporation is a domestic non-profit corporation and the address of its current registered office in this Commonwealth is: 301 Iven Avenue, #315, Wayne, Pennsylvania 19087 (Delaware County).
3. The name and registered office address of the non-surviving party to the merger, which is not qualified in Pennsylvania, are: PAISBOASUB, Inc., c/o Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808.
4. The plan of merger (the "Plan of Merger") shall be effective upon filing these Articles of Merger in the Department of State.
5. The Plan of Merger was adopted by the directors and members of Philadelphia Area Independent Schools Health Insurance Group pursuant to 15 Pa.C.S. § 5924(a).
6. The Plan of Merger was authorized, adopted, and approved by the foreign nonstock corporation party to the Plan of Merger in accordance with the laws of the jurisdiction in which it is incorporated.

Pursuant to 15 Pa.C.S. § 1901 (relating to omission of certain provisions from filed plans), the provisions, if any, of the Plan of Merger that amend or constitute the operative provisions of the Articles of Incorporation of the surviving corporation as in effect subsequent to the effective date of the Plan of Merger are set forth in full in Exhibit A attached hereto and made a part hereof. 

EXHIBIT A

In connection with the merger and as set forth in the Plan of Merger, the Articles of Incorporation of Philadelphia Area Independent Schools Health Insurance Group shall be amended as follows:
