
TO WHOM IT MAY CONCERN:


3. That, by agreement of the parties, paragraph 3(a)
of the complaint of C0601 is withdrawn.

4. That the captioned complaints are sustained in
part, consistent with the terms of the Settlement Agreement.

5. That Linda G. Krein, t/a We Care Limousine
Service, having agreed to do so, and pursuant to Section 3301 of
the Public Utility Code, 66 Pa. C.S. §3301, shall remit a civil
penalty of six thousand five hundred and fifty dollars
(\$6,550.00), satisfying all three consolidated complaints payable
by money order or certified funds to the Pennsylvania Public
Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265,
within 30 days after the Commission's Order in this case is
entered.

6. That Linda G. Krein, t/a We Care Limousine Service
shall cease and desist from further violations of the Public
Utility Code or applicable regulations of the Commission.
