This letter has two-fold purpose in response to a February 19, 2016 letter and reply to exceptions signed by Ms Lee, Esq of PECO:

- 1) To document the continued twisting and turning of words and procedures from members of PECO and now evidenced by the PUC;
- 2) To restate for a fourth time the true matter at hand with copy of documentation.

The above-listed letter contains the following **ERRORS** (untruths), thereby infecting Ms Lee's "reply exceptions" which are completely inappropriate to the process thus far:

- 1) That Nancy and Jim Colbert filed Exceptions with the PUC;
- 2) That "no additional attachments" accompanied the documentation received on January 19, 2016 (9:43 AM signed by Ulrich) at the PUC.
- 3) That "the real world force awakens – in all of us" letter was written by Nancy and Jim Colbert.

ALL OF THE ABOVE ERRORS RESULTED FROM MS LEE'S IGNORANCE OF THE LETTER RECEIVED BY THE PUC ON JANUARY 19, 2016, ALSO MAILED TO HER SEPARATELY. THAT LETTER SIGNED BY NANCY COLBERT STATES, NOW DOCUMENTED FOR A SECOND TIME:

- 1) That Judge Salapa's dismissal lacked signature which is a violation of due process. It was returned for signature.
- 2) WORSE, that Judge Salapa stated in this dismissal that NO response to the Primary Objectives and New Matter were filed by Nancy and Jim Colbert. **UNTRUTH - SEE ATTACHED 12/28/15 PUC DOCUMENTATION. IN FACT, COMPLAINANTS DISCOVERED THAT UPS ATTEMPTED DELIVERY ON JANUARY 5, 2016 BUT THE PUC PREVENTED IT. UPS HAD TO RETURN ON JANUARY 6, 2016, WHILE, EVEN WORSE, JUDGE SALAPA WROTE HIS DISMISSAL ON JANUARY 7, 2016 BEFORE THE 10-DAY WINDOW. SUCH DENIAL OF THE COMPLAINANTS RESPONSE IS A VIOLATION OF DUE PROCESS and therefore that dismissal is dismissed with prejudice.**
- 3) THE LETTER STATES THAT THE COMPLAINANTS STILL AWAIT A SIGNED PUC RESPONSE TO THAT RESPONSE TO Primary Objectives and New Matter IN ORDER FOR DUE PROCESS TO OCCUR.
- 4) **Attached to the letter:** new evidence a PUC's Bureau of Investigation and Enforcement might want to consider since the public is becoming more aware of corruption along with Rep. Godshall's obstruction of due process. By the way, knowledge of the threat to public health is also increasing – see TEDxBerkeley "Wireless Wake Up Call". People are tired of being sickened once "smart" meters are installed on their homes, and their usage sold for profit.

THEREFORE, NO Exceptions have been filed by Nancy and Jim Colbert. Even though Ms Lee's response to nonexistent exceptions contain many errors (untruths), including many references to a copy of an essay written by the TAKE BACK YOUR POWER team (stated within the essay) as if written by the Colberts, it is dismissed with prejudice for incorrect due process and content.


