





Information before this Commission indicates that:

- (1) That by advertising in the McCandless, Pine, Wexford, Pennysaver newspaper covering the Allegheny County area, you held yourself out to transport household goods for compensation between points in the Commonwealth of Pennsylvania.

52 Pa. Code §21.1(i)(ii) - Household goods in use

As used in connection with transportation, the term means personal effects and property used or to be used in a dwelling when a part of the equipment or supply of the dwelling, and similar property if the transportation of the effects or property is one of the following:

- (i) Arranged and paid for by the householder, including transportation of property from a factory or store when the property is purchased by the householder with intent to use in his dwelling.

- (ii) Arranged and paid for by another party.

Household goods in use carrier-A motor common or contract carrier that transports household goods in use.

- (2) You must also include your certificate number in any advertisements.

52 Pa. Code §21.2 - Advertising by common carriers of passengers or households goods in use.

A common carrier of passengers or households goods in use which advertises its services as an intraState carrier within this Commonwealth shall include in the advertisements its certificate number issued by the Commission. A common carrier of passengers or households goods in use which does not comply with this section shall be subject to penalty under 66 Pa.C.S. §§ 3301-3315) relating to violations and penalties).


Since you do not hold authority to transport household goods in use issued by this Commission authorizing you to provide such service, you have violated the provisions of the Public Utility Code at 66 Pa. C.S. §1101.

You are hereby directed to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§101, et seq. and the regulations of this Commission, 52 Pa. Code §§1.1, et seq.

We received an application for household goods in use from you on May 22, 2007. The application was returned to you on June 1, 2007 for additional information. As of today's date, we have not received the application back. If you wish to transport household goods in use between points in the Commonwealth of Pennsylvania, it is necessary that you send back the application with the information requested. If you have any questions regarding the additional information that is needed on the application, please direct them to the Compliance Office at 717-787-1227.

Dear Ms. Kissel:

Your informal complaint against Deliver Today, Inc. at Application Docket No. A-00111241 has been investigated by Enforcement Officer Supervisor Cynthia Hawthorne of the Commission's Pittsburgh District Office. In your complaint it was alleged that Delivery Today, Inc. advertised as a household goods carrier for compensation without proper authority.

In the course of the investigation, it was found that the carrier was not aware of the need to have separate authority to operate as a household goods carrier. The Enforcement Officer educated the carrier on Public Utility Commission household goods authority and he was cooperative and is going to correct the problem. At this time no further action will be taken.


