ORDER SUSPENDING
CERTIFICATE OF PUBLIC CONVENIENCE

BY THE COMMISSION:

This matter comes before the Commission upon letter-petition of Jeffrey R. Larson received on September 21, 1995, advising that Jeffrey R. Larson has temporarily ceased operations and requests that his certificate of public convenience be suspended, through January 19, 1996.

In view of this petition, we will grant the suspension and allow the petitioner a reasonable period of time to resume operations. We determine that an appropriate period of time would be one year from the date his insurance was cancelled.


Petitioner is reminded that the grant of this request does not relieve the petitioner of the responsibility to pay any fines or fees due; THEREFORE,

IT IS ORDERED:

1. That the certificate of public convenience issued to petitioner at A-00111241 be and is hereby suspended effective upon entry of this order.

2. That petitioner shall not operate while under suspension.
3. That upon written notification that petitioner intends to resume operations and upon compliance with the Commission's rules and regulations regarding insurance, the suspension shall be lifted.
4. That petitioner shall resume operations on or before September 13, 1996.
5. That if petitioner has not resumed operations on or before September 13, 1996, a complaint will be instituted.
