Planet Energy (Pennsylvania) Corp. ("Planet Energy") hereby files this Certificate of Satisfaction of the Complaint by Brenda and Joseph Zellies, pursuant to Section 5.24(b) of Title 52 of the Pennsylvania Code, 52 Pa. Code §5.24(b), and in support thereof does state as follows:

On September 8, 2015 Brenda J. and Joseph Zellie ("Complainants" or, collectively, "Zellie") filed a formal complaint against Planet Energy alleging they had not been informed there was a cancellation fee, and thus requesting that an adverse credit report statement be reversed and collection efforts dismissed.

Subsequently, Planet Energy has resolved the matter by agreeing to dismiss or otherwise cause a cessation of all collection efforts, by correcting any adverse credit report reference(s), and by paying an amount considered satisfactory to Complainants to compensate for inconvenience or costs in pursuing this matter.
