Dear Secretary Chiavetta:

Nasser Limousine, LLC (Respondent) has paid the entire civil penalty sought by the Bureau of Investigation and Enforcement (I&E) of the Pennsylvania Public Utility Commission (Commission) in order to satisfy the above-docketed proceeding.

On February 10, 2016, I&E filed a Complaint alleging that Respondent offered a coupon that charged limousine rates other than the amount described in Respondent's tariff on file with the Commission in violation of 52 Pa. Code § 29.334 and that Respondent offered to transport, as a common carrier by motor vehicle, persons in limousine service from a different territory than that authorized by its Certificate of Public Convenience in violation of 66 Pa.C.S. § 1102. I&E requested that Respondent pay a civil penalty in the amount of \$600.

On February 25, 2016, the Commission received payment from Respondent by cashier's check in the amount of \$600, which constitutes the entire civil penalty in this matter.

Accordingly, pursuant to 52 Pa. Code § 5.24(a), I&E files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed.


