Attached for eFiling in the above-captioned matter is an original AMENDED Certificate of Satisfaction of Complaint under 52 Pa. Code § 5.24(b).


This AMENDED Certificate of Satisfaction is being refiled because the docket number on the letter was incorrect. The docket number has now been corrected and is being refiled.


(b) Complainant agrees to withdraw her Complaint.


