CERTIFICATE OF SATISFACTION

1. Complainant is Mimose Innocent.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainant, Mimose Innocent, and Respondent, PPL Electric, agree as follows:
 - (1) Complainant will make a lump sum payment towards arrearages of \$1,000.00, by March 25, 2016.
 - (2) Complainant will make a second lump sum payment towards arrearages of \$500.00 within sixty (60) days of the date of this Certificate of Satisfaction.
 - (3) Complainant has agreed to be placed on the budget bill. Currently the budget bill amount will be \$425.00, starting with the bill due March 2016 (at this time, it is estimated that the bill due date will be on or about March 29, 2016).

(4) Thereafter, beginning with the bill due April 2016, Complainant will pay her budget bill plus \$300.00 per month towards arrearages until all arrearages are paid in full.

(b) It is further agreed between the parties that PPL Electric will conduct a high bill investigation during regular business hours.

(c) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.


