

**PREHEARING MEMORANDUM OF  
THE PHILADELPHIA INDUSTRIAL AND COMMERCIAL GAS USERS GROUP**

---

Pursuant to the March 7, 2016, Prehearing Conference Order issued by Administrative Law Judge Marta Guhl, the Philadelphia Industrial and Commercial Gas Users Group ("PICGUG") hereby submits this Prehearing Memorandum in the above-captioned proceeding.

**I. HISTORY OF THE PROCEEDING**

On January 29, 2016, the Philadelphia Gas Works ("PGW") submitted its Gas Cost Rate ("GCR") pre-filing with the Pennsylvania Public Utility Commission ("Commission") pursuant to Section 1307(f) of the Public Utility Code, 66 Pa.C.S. § 1307(f).

On February 11, 2016 PICGUG filed a Petition to Intervene in this proceeding. A description of PICGUG is set forth in PICGUG's Petition to Intervene. PICGUG's Petition to Intervene is pending and awaits disposition by the ALJ.

On March 1, 2016, PGW filed its 2016-2017 GCR filing pursuant to Section 1307(f) of the Public Utility Code, 66 Pa.C.S. § 1307(f).

A Prehearing Conference has been scheduled in this proceeding for March 16, 2016.

**II. ANTICIPATED ISSUES AND SUB-ISSUES**

PICGUG is concerned with the following issues:

- a) whether PGW's proposed Tariff, as filed, fully justifies its requested relief; and
- b) whether PGW's proposed retainage fee is properly calculated.

PICGUG anticipates pursuing these issues during this proceeding and reserves the right to raise further issues, as well as to respond to all issues raised by other parties.

**III. PROPOSED WITNESSES**

PICGUG is currently evaluating whether it will sponsor testimony in this proceeding. If PICGUG opts to sponsor testimony, it will immediately inform the parties and the ALJ of any intended witnesses and their areas of testimony. PICGUG also intends to participate in this proceeding through the submission of discovery, cross-examination of other parties' witnesses, and the submission of briefs, exceptions, and reply exceptions, if necessary.

**IV. PROPOSED SCHEDULE AND DISCOVERY RULES**


PICGUG will cooperate with other parties to develop a mutually acceptable schedule for discovery and testimony. To the extent necessary, PICGUG will also cooperate with the ALJ and the parties at the Prehearing Conference to address any requested modifications to the Commission's standard discovery rules in accordance with the Commission's Regulations and any directives issued by the ALJs.

**V. POSSIBILITY OF SETTLEMENT**

PICGUG is willing to participate in discussions with the other parties to amicably resolve the issues in this proceeding.
