

CERTIFICATE OF SATISFACTION

1. Complainant is Michael Scotto.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainant, Michael Scotto, and Respondent, PPL Electric, agree as follows:

(1) PPL Electric will make an immediate referral of Complainant to the OnTrack Program. Such referral was previously made on February 23, 2016, but as Complainant indicates he has not received the enrollment package. Another referral will be made by PPL.

(2) Beginning with the bill due on or about April 26, 2016, Complainant will pay his monthly charges plus \$93 per month towards arrearages until all arrearages are paid in full. In the event Complainant is accepted onto OnTrack, any OnTrack payment arrangement will supersede this arrangement. However, until such time as Complainant

is accepted into the OnTrack Program, Complainant shall make monthly payments consistent with this Agreement.

(3) PPL Electric Customer Representative has agreed to inform her supervisor of Complainant's concern with the clarity of the OnTrack letter notifying customer that they are close to full use of the OnTrack benefit allotment.


(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.


